If coming from Houston/Clear Lake area on I-45 South

- 1. Take Exit 10 (FM 519/Main Street). Immediately get in far right lane.
- Take FM 519 West, which is a turning lane to the right, and is BEFORE the traffic light.
 If you miss the turning lane, continue to the traffic light and turn right. At the Stop sign, turn right, and at next Stop sign, turn left onto FM 519.
- 3. Drive approx. 1 mile, destination is on right.

If coming from Galveston area on I-45 North

- 1. Take Exit 10 (FM 529/Main Street). At stop light, turn left and go under the overpass.
- 2. At the Stop sign, turn right, and at next Stop sign, turn left onto FM 519.
- 3. Drive approx. 1 mile, destination is on right.

If coming from Alvin area on TX-6 South

- 1. Turn left onto FM 519/Main St. FM 519 is approx. 2 mi. South of Galveston Co. Fairgrounds
- 2. Drive approx. 1 mile, destination is on left. If you make it to the 4-way stop at Vauthier Rd... you've gone too far.
