### Small Farm Outreach Training & Technical Assistance Program

- A program that is administered from the Cooperative Extension Program at Prairie View A&M University.
- The program has been in the Rio Grande Valley for 22 years. The counties covered by the Program are: Hidalgo, Starr, Cameron and Willacy

#### Program Objectives

- Enhance the business management and marketing skills of Farm Service Agency borrowers.
- Implement outreach programs to acquire loans for small, limited-resource, socially disadvantaged and beginning farmers and ranchers.
- Develop the financial documentation necessary for producers to obtain loans from FSA.

#### **Outreach Efforts**

- The program extends its outreach efforts to the counties of Hidalgo, Starr, Cameron and Willacy.
- Collaboration with USDA-Farm Service Agency personnel in the four counties.
- Collaboration with the four Texas Agrilife County Extension Agents in the Rio Grande Valley.

#### Outreach Efforts (continued)

- Collaboration with USDA-Natural Resources Conservation Service in each county.
- Collaboration with local agribusiness.
- Collaboration with Texas-Mexico Border Coalition

#### **Small Farm Advisory Committee**

- A group of eight ag producers, which include: farmers, ranchers, a crop insurance agent and a livestock auction owner.
- They provide direction for our programming efforts by telling us the needs and concerns of ag producers in their areas.
- They volunteer their time by providing outreach on our programs to others in their community.

#### **Evaluation of Programs**

- Each program participant is handed a retrospective post evaluation form at the end of each program to see if knowledge was gained due to the program.
- Program participants will provide topic requests for future programs.
- Useful tool to help improve programming efforts.

#### **Technical Assistance Process**

- Producers inquire about loans at the USDA-Farm Service Agency and get sent to us.
- Agent sends a checklist to the client of what is needed to complete the FSA loan application.
- The client then calls us to set up an appointment.
- We sit down with the client for 2 to 8 hours to complete all the necessary forms.
- We sometimes meet again with the client if FSA needs additional information from them.

### Small Farm Outreach Training and Technical Assistance Program

- Producers have been able to purchase the following with USDA/FSA loan funds:
- Livestock (Cattle, goats)
- Machinery (Tractors, combines, farm equipment)
- Land (Several ranches and farmland acres purchased throughout the years)
- Refinance debts (Producers have been able to stay in business with the help of these loans)

### Small Farm Outreach Training and Technical Assistance Program

• The most important purpose of the SFOTTAP is that all of the barriers that have impeded the program participant's full participation in USDA-Farm Service Agency loan programs have been and will continue to be removed.

#### Information Needed To Complete USDA Farm Service Agency Loan Application Packages

- 1) Last 3 years of income tax returns and income and expenses for the current year.
- 2) Last 3 years of **production histories** and **production** for the **current year**.

For crop producers: Crop produced and yield/acre

For livestock producers: % calf crop and average weaning weights

3) List of all **creditors**. (Farm related and personal)

Provide: Names

Addresses

Account Numbers Approximate Debt

- 4) Producer **Farm data report** and **Form 156-EZ** from the USDA-Farm Service Agency office.
- Form CPA-026 obtainable from your local Natural Resources Conservation Service Office.

(This document tells if there is a conservation plan in place with that particular producer and assigns an erodibility index to the farm being operated by that producer)

6) Projections and goals for next years proposed operation.
