7) Steps to become a Private Applicator

Training Day Instructions

1) **Registration:** Collect fees

- Make sure each applicator has a copy of both manuals (AES-1648 & AES-5056). (required for training)
 - If County Extension Office provides books = \$55.00
 - If Applicator purchased books prior to training = \$10.00
- Make sure participants are in the right location and eligible to train. Only those wishing to get a "Private" Applicators license will go through this training. If someone has previously had a private applicator license, that license must have been expired at least a year before they can retrain and retest.
- 3) Give each applicator D-1411: Private Applicator Training Verification form and have them fill out Section A
- 4) Handout to applicators: (these forms can be used following training for home study prior to testing)
 - 1) Private Applicator Note Taking Worksheet No Answers (fill in the blank)
 - 2) Private Applicator Note Taking Worksheet Answers (to help them follow along)
 - 3) Private Applicator Calibration Worksheet (include formulas and practice questions)
- 5) Pick up Training Verification Forms, Agent fill out Section B
