4-H Enrollment

4-H Enrollment starts <u>August 15th</u>!!! All enrollment is done via 4-H Connect. You can access 4-H Connect by going to our 4-H website at http://agrilife.org/bell4h/ and clicking on the 4-H Connect icon.

To maintain the level of programming and opportunities in the Texas 4-H and Youth Development Program, an annual participant fee is implemented for each 4-H member (excluding Clover Kids). The participant fee is \$25 if enrolled from August 15th to October 31st, November 1st the participant fee will increase to \$30.

Please do not worry if you are still pending at the county level once you have enrolled. The county office will try to keep up as best as we can by approving them at least once a week. As long as you complete your enrollment, you are in the system and good for enrollment and BCYF requirements. Enrollment dues must be paid by an electronic payment.

All volunteers who enroll will be charged \$10.00. This covers your screening for the year. All volunteers will have to re-enroll each year. Club Managers must enroll ASAP!

4-H Age /Grade Requirements

Texas 4-H membership eligibility will be based on SCHOOL GRADE and not age. The eligibility rules and guidelines are:

Youth may participate in 4-H year from September 1st of grade three through August 31st following completion of grade twelve, with these age restrictions:

Minimum age - 8 (as of August 31, 2019 and in the 3rd grade)

Maximum age - 18 (as of August 31, 2019)

Juniors: Grades 3, 4, and 5

Intermediates: Grades 6, 7, and 8

Seniors: Grades 9, 10, 11, and 12

Livestock projects not on feed and in daily care of the exhibitor/family by the ownership deadline listed will NOT be validated.

Reminders for 2020 Major Show Sheep and Goat Exhibitors

The ownership and registration deadline for breeding sheep and goats is **October 1**. The animal must be recorded in the association herdbook in only the exhibitor's name by that date. A color copy of the original registration papers **MUST** be sent to whitney.grantham@ag.tamu.edu **PRIOR** to the physical validation date for approval, or feel free to bring the original papers by the Extension Office to be scanned and uploaded.

Texas Lamb Breeders Association (TLBA) tag numbers MUST be in the lamb's ear and be recorded on the validation form at validation. NO TLBA tag numbers will be added to the validation forms after physical validation. Market lambs must have a yellow TLBA tag to be eligible to compete in the San Angelo Stock Show or receive TLBA recognition at other major shows. Wether dams must have a red TLBA ewe lamb tag to be eligible to compete in the San Angelo Wether Dam Show.

The Texas Goat Breeders Association (TGBA) is new this year. TGBA tag numbers must be in the goat's ear and recorded on the validation form at the time of validation. Market goats and wether does are eligible for this program and will have the same green TGBA tag. The TGBA tag is not required for entry into any show this year, but premiums will be awarded to exhibitors with TGBA tags.

NEW for 2020 San Antonio Gilt Exhibitors

The ownership and registration deadline for all purebred gilts going to San Antonio is December 1st. This year, gilts are required to be registered in the Herd book of their Association in only the name of the junior owner on or before December 1, 2019. The show will not accept a family-validated or family-registered gilt of any kind as a valid entry. Uploads must be the original registration certificate. No other forms will be accepted.

If you are planning to validate a Purebred gilt for San Antonito, please send a <u>COLOR SCAN</u> of the original registration papers to <u>whitney.grantham@ag.tamu.edu</u> <u>PRIOR</u> to validation so that she can upload all papers to the online system. You may come by the office at any time to have those scans made. Also, please bring your original registration papers with you to validation for verification!

Major Show Heifer Validation

WHEN: October 28, 2019 WHERE: Bell County Expo TIME: 4:00—7:00 pm

A <u>COLOR SCAN</u> of the original registration papers must be sent to Whitney <u>PRIOR</u> to validation so that she can upload all papers to the online system. You may come by the office at any time to have those scans made. Your heifers must be properly tattooed <u>BEFORE</u> arrival. Also, please bring your original registration papers with you to validation for verification!

All **BCYF only Unregistered Heifers** must fill out an Unregistered Heifer Validation form prior to arrival in addition to being physically validated with a tag and county number tattoo on October 28th. County only tags will be purchased on-site the night of validation for \$5 per head.

Bell County Youth Fair Eligibility

Club Managers, please make sure you have a sign in sheet at each meeting and announce to all members to sign in before, during, and after the meeting.

- BCYF has a website in which everything will be posted including the new fair book, entry forms, superintendent's names and phone numbers, score sheets, and other information: http://agrilife.org/bellctvyouthfair/
- You MUST attend 2 meetings to participate in the BCYF. Your name MUST be on the sign in sheets for it to count.
- 2 meetings will be allowed from <u>August 1, 2019 to December 31, 2019</u> this year. No meetings will be allowed in January to use for the 2 meeting rule.
- All 4-H members MUST be enrolled by <u>December 10, 2019</u> to participate in the BCYF. However, the fee will go up after October 31st so do it quickly.

CHANGES this Year!

- All entries will be made online. Exhibitors will be required to complete an online entry process. Club Managers will then review and approve their club entries. The online entries will shut down promptly on December 1st at 5:00 pm. We will send out more information with instructions and website soon.
- No swine carcass contest for 2020.
- **All entry fees have increased**. FCS entries are now \$7 per entry. All livestock entries have increased by \$5. Alternate horses went up to \$5 per entry. Livestock showmanship has stayed at \$10.
