4-H Enrollment

4-H Enrollment starts <u>August 15th</u>! All enrollments are done via 4HOnline. You can access 4HOnline by going to our 4-H website at http://agrilife.org/bell4h/ and clicking on the 4HOnline icon. <u>V2.4honline.com</u>.

A youth that is 8 years old and going into the 3rd grade must wait until September 1st to enroll for correct fees to be charged.

To maintain the level of programming and opportunities in the Texas 4-H and Youth Development Program, an annual participant fee is implemented for each 4-H member (excluding Clover Kids). The participant fee is \$25 if enrolled from August 15th to October 31st, November 1st the participant fee will increase to \$30.

Please do not worry if you are still pending at the county level once you have enrolled. The county office will try to keep up as best as we can by approving them at least once a week. As long as you complete your enrollment, you are in the system and good for enrollment and BCYF requirements. Enrollment dues must be paid by an electronic payment.

All volunteers who enroll will be charged \$10.00. This covers your screening for the year. All volunteers will have to re-enroll each year. Club Managers must enroll ASAP!

4-H Age /Grade Requirements

Texas 4-H membership eligibility will be based on SCHOOL GRADE and not age. The eligibility rules and guidelines are:

Youth may participate in 4-H year from September 1st of grade three through August 31st following completion of grade twelve, with these age restrictions:

Minimum age - 8 (as of August 31, 2023 and in the 3rd grade)

Maximum age - 18 (as of August 31, 2023)

Juniors: Grades 3, 4, and 5

Intermediates: Grades 6, 7, and 8

Seniors: Grades 9, 10, 11, and 12

4-H Club Incentives

We want to continue to incentivize member participation. In that effort, each Club that meets the 3 requirements listed below will earn a 10% kickback.

- 1. 100% ticket sales based on enrollment from last year based on each member selling 3 tickets.
- 2. Donate \$100 to the Bonus Draw side raffle.
- 3. Recruit at least one \$200 event sponsor

For example: if your club is given 100 tickets to sell based on last year's membership, you will receive the 10% kickback if you sell those 100 tickets, recruit at least one \$200 event sponsor, and donate \$100 to the Bonus Draw side raffle.

4-H Member Incentives

The 4-H member with the highest number of ticket sales, will get \$100 cash! This does not include tickets sales from the Bonus Draw (Ambassadors only). Make sure to complete the "sold by" portion on your tickets to get credit! Club Managers will have to keep track of this and share with the Extension Office on their club's highest seller and the number of tickets they sold.

2023 State Fair of Texas & Heart O' Texas Fair Entry Deadline

If you are attending the **State Fair of Texas & Heart O' Texas Fair**, please see the entry information below. Entry forms and payment are due to the CEO by **August 16**th, **2023**. No late entries will be accepted.

Youth livestock entries must include a current Quality Counts number. For exhibitors entering $3^{\rm rd}$, $6^{\rm th}$, or $9^{\rm th}$ grade this year, you must take the course. The Quality Counts system is down for maintenance now, but is expected to reopen on August $1^{\rm st}$, 2023. To begin a new course enrollment, visit https://

www.texaslivestockvalidation.com/qc/qcregister.aspx.

Exact cash or checks can be made payable to the Bell Livestock Coalition. Credit Card payments will incur a 3% fee. Entry forms will not be accepted without payment.

State Fair of Texas Entry Process: Fill out paper entry form, enter information into online parent portal, and bring form to the Extension Office with payment by **August 16th**, **2023**. The schedule, premium book, and additional entry forms can be found at https://bigtex.com/get-involved/livestock-shows/livestockexhibitors/.

Visit https://livestock.bigtex.com/login/ (after August 1st) to login or create your SFT Parent Portal account. Upon completion of submitting your entries they are directed to your ag teacher or county agent's queue. All exhibitors must electronically complete and sign: 1. Release of liability and indemnity agreement AND 2. W9 that includes a social security number.

• **Heart O' Texas Entry Process:** Fill out paper form and bring form to the Extension Office with payment by **August 16**th, **2023**. The schedule, premium book, and additional entry forms can be found at https://www.hotfair.com/p/livestock-show--contests.

2024 Major Show Lamb and Goat Validation Tag Orders

It is time to place state validation tag orders for lambs and goats going to **2024 Spring Major Shows!**Bell County **REQUIRES** all FFA and 4-H members to pre-order and pay for Major Show tags prior to validation.
Major Show tags are **\$20/each**. Livestock validated for Texas Major Shows are automatically validated for the Bell County Youth Fair at no additional cost during validation. Validation tags for only the county show will be purchased on-site during physical validation for \$5/each. Completing validation does NOT enter livestock in the shows. Major Show entries will be handled through your County Extension Agent or Ag Teacher. Bell County Youth Fair entries will be completed online. For more information, please contact your County Extension Agent or Ag Teacher.

Registration Papers Required For Registered Sheep & Goats

The deadline for ownership, transfer, and registration is October 1, 2023. A color copy of the original registration papers MUST be sent to Whitney.Ingram@ag.tamu.edu prior to validation.

There are two options for exhibitors to submit tag orders:

- o To order online and pay by credit card, visit: https://bell-livestock-coalition.square.site/
- o To **order in person or by mail** and pay with exact cash or check, please complete the attached order form and mail or deliver to the Extension Office with payment, payable to *Bell Livestock Coalition*.

Physical validation will be held at the **Bell County EXPO** on the dates listed below:

Sheep and Goat Validation: October 17th and October 24th from 4:00 – 7:00 pm

Special Notes for Sheep and Goat Validations:

- *NEW FOR 2023* All lambs and goats validated during the 2023 State Fair Validation period including market animals WILL BE ELIGIBLE for 2024 Spring Major Shows. Once validated, the project MUST stay in the care of the exhibitor that project is validated to; if the exhibitor chooses to sell the project to a new exhibitor, the new exhibitor MUST REVALIDATE the project within the next validation period.
- Texas Lamb Breeders Association (TLBA) and Texas Goat Breeders Association (TGBA) tag numbers MUST be in the animal's ear to be recorded on the validation form at validation. All lambs and goats planning to go to San Angelo MUST have TLBA/TGBA tags in their ear and the number recorded on their validation form.
- If a TLBA/TGBA tag is added to the animal's ear after the State Fair show season, then the animal must be revalidated during the Major Show Validation season in order for the TLBA/TGBA tag number to be properly recorded on the Validation Form and eligible for TLBA/TGBA premiums during the spring show season.
- In 2021, Sheep and Goat Validation of Texas announced the introduction of the Roll-over Breeding Sheep and Breeding Goat program. For example, any BREEDING animal validated during the State Fair 2021 validation period is eligible to be exhibited by that exhibitor through the State Fair 2024 show season. If ownership changes, then the animal must be re-validated.
- All sheep and goats are eligible for family validation. Registered sheep and goats can family validate if the registration papers have all exhibitors full names listed as owners. Registration paper ownership will determine the exhibitors eligible to show that project.
- All Market Lambs, Market Goats, Breeding Sheep, Wether Dams, Breeding Goats, and Wether Does will use the same RFID validation tag.
