# Finance Committee: Shelley Young

- Account balances and excess funds discussed
- Proposed budget based on amounts from 2 years ago
- Discussed possibly using excess funds to benefit clubs and kids.
- Consider Hunter Spectacular ticket sale kickback increase to 20% for this year
- Discussed removing the \$100 club Hunter Spectacular donation
- Discussed increasing scholarship monies
- Even with the large amount of excess funds, we will need to be cautious about future fundraising and expectations
- Discussed possibly moving excess funds to savings vs. another CD
- Discussed option of paying for shooting sports coaches as many are leaving and there is a need to have new coaches to take over. Also possibly establishing a budget line item for it
  - Motion made by B. Wood to reimburse shooting sports coaches for registration fees, and \$200 to cover mileage and per diem. Seconded by E. Steglich, motion carried
  - Motion made to increase Line 407 to cover the proposed costs associated with shooting sports to \$5,000, and seconded. Motion carried
- To used surplus funds, a motion was made by E. Steglich to create a new budget line item for the use of surplus funds as a "Mini-Grant" in the amount of \$20,000. Seconded by B. Farmer. Motion carries. Process will involve an application that will be developed by Sheryl. She will send out for critique.

- To use surplus funds, a motion was made by S. Hoelscher to use \$2,0000 for an end of year party. Seconded by D. Brown. Motion carried. Funds will come out of budget Line 411.
- To use surplus funds, S. Hoelscher motioned to increase the Hunter Spectacular club ticket sale kickback to 20% for this year. Seconded by J. Canales. Motion carried

**Hunter Spectacular:** Discussions held throughout the meeting. Gun Committee to wait until the beginning of next year for bid solicitation.
