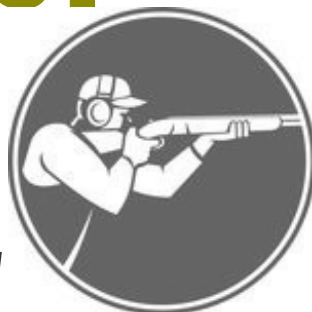

Registration is available through iclays.com. If you have any questions you can email us at navarrocountyshtogunteam@yahoo.com. This shoot is limited to the first 200 registered 4-H shooters for Whiz-Bang & Sporting Clays.

Deadline for registration: November 1, 2017; registrants signing up after November 1st, will have an additional fee of \$25.00.

If you would like to reserve a golf cart for the tournament, please contact Caney Creek Lodge for arrangements. Go to www.caneycreeklodge.net to reserve a cart online.

Any reckless or careless driving will result in removal of that driver from the course until the end of the event. No exceptions.

This is a 4-H event; therefore all entrants must be members of Texas 4-H Club for the current year.

Check-in will start at 7:30AM; and safety briefing will begin at 8:00AM; and shooting will begin at 9:00AM.

Payment

Payment can be received on www.iclays.com.

When paying by personal check, any returned check will result in cancellation of the entry/entries that the check was paying for. To re-enter you must pay a \$30.00 return check fee. This option will only be available if there is open space remaining.

Return Policy/Refunds:

Refunds minus a \$25.00 registration fee will be made to any shooter who cancels between **November 1—November 13, 2017**. NO refund will be made for cancellations or no-shows after **November 13, 2017**.

All refund requests must be received in writing by one of the following methods: e-mail, US Mail (at the address provided in the right hand column). All refunds will be processed and granted after the tournament is complete.

Silent Auction:

Any ties in the Sporting Clays event will be decided by a Station Tie Breaker. All other events will have the tie settled by a shoot-off.

Parent/Coach/Siblings on Field:

First and foremost, all parents, coaches and siblings MUST have protective eyewear and earwear. If this is not present on each observer, you will be asked by a marshal to leave the course. No coaching will be allowed while the youth shooter is on the field or in the cage during events. For safety reasons, parents will not be allowed on the skeet/whizbang fields.

Protest Procedure

Protests should be initiated immediately the field referee and can only be initiated by the shooter. No protest will be accepted from parents and/or coaches.

Code of Conduct

The current 4-H Code of Conduct will be enforced both on and off the field during this event. Shooters, volunteers, family members or observers may be expelled for the event, match or grounds for failure to comply. Shoot management reserves the right to refuse future registration to any shooter who does not comply with the current 4-H Code of Conduct.

Please fill out and return the Shooting Agreement and Waiver of Liability form and return with the registration form. Each shooter (youth and adult) will need to sign the attached waiver. **Your registration will not be processed unless all forms are returned together.**

Directions to Caney Creek Shooting Club:

Interstate 45 to Fairfield exit #197. Take a right on US Hwy 84 going west to Teague. Turn right on FM 1367. Go 2.1 miles to Sheffield Ranch and take a left. Go.7 mile to the "Y" and follow the road to the right, stay on the paved road. Cross the wooding bridge and follow the road 1.2 miles to the first house on the left with "Caney Creek Lodge" above the gate.
