**AGE DIVISIONS:** There will be three age divisions for all Judging Contests. Age division is

determined by the grade as of August 31, 2018.

Juniors – 3<sup>rd</sup> Grade (and 8 years old) – 5<sup>th</sup> Grade

• Intermediates – 6th – 8th Grade

Seniors – 9<sup>th</sup>- 12<sup>th</sup> Grade

**TEAM/INDIVIDUAL:** Counties may enter as many teams as needed and up to 2 individuals in judging contests in each age division. All youth entered in each age division will be eligible for high point individual awards.

MATERIALS: Scantrons will be provided for all participants at the judging contests.

Contestants will be required to bring two (2) #2 pencils and one clipboard.

**MAPS:** Included is a map to the Gillespie County Fairgrounds.

## **VOLUNTEERS TO ASSIST WITH CONTESTS:**

All of the District Judging Contests will need additional volunteers to help as group leaders, tabulators, etc. Agents will need to recruit and CONFIRM ONE volunteers who can serve in these roles. A link is provided for agents to complete and return to the District Office by April 5, 2019.
