  - Check-in will start at 9:00 AM. The judging will be on October 7<sup>th</sup> at 2:00 PM.
  - Shana is looking for help with JCCA. Please let Shana know if you would like to help and PLEASE start recruiting judges and runners. Many of the judges have mobility issues and are unable to bend down.
