

Brazoria County 4-H 2024 20 Gun Fundraiser RULES

Tickets may be picked up January 29th from the 4-H office.

Raffle Club Rules for 2024

- There will be only 2000 tickets to be sold during the duration of the raffle.
- The price is set at \$20.00 per ticket.
- The purchaser must be at least 18 years of age and does not need to be present to win.
- The drawing will occur at the **Brazoria County Council meeting, April 22, 2024**. Watch the drawing live on the Brazoria County 4-H Face Book page.
- Winners will be contacted and will be required to present ID to claim gift certificate for the amount of the listed price of the firearm on the ticket.
- Prizes must be collected within 30 days of drawing, or they will be forfeited to Brazoria County 4-H.
- Prizes must be picked up at **Irwin's Toy Box – 203 Fillmore Street, Sweeny, Texas 77480**
- Clubs and members missing unsold tickets at time of turn in are responsible to pay for missing tickets.

Deadlines & Rules – Both deadlines will count towards 10% club profit checks, and top seller totals.

- **April 1st, 2024**
 - Any unsold tickets by members must be turned in at this time by Club Sales Chair.
 - Must pay for sold tickets with 1 club check. No cash will be accepted.
- **April 2nd, 2024**
 - Members may pick up raffle tickets.
- **April 15th, 2024**
 - Any unsold tickets by members must be turned in at this time by club members guardian or Club Sales Chair.
 - Must pay for sold tickets with 1 CHECK or MONEY ORDER. No cash will be accepted.

Distribution & Turn in of Tickets

- Initial distribution of tickets will be based on 2023 club total sales. Total number distributed may be rounded down to increments of 5.
- Member distribution of tickets will depend on how many tickets are turned in on April 1st.
- If club did not sell tickets during 2023 fundraiser, distribution of tickets will be based on 3 tickers per club member.
- The 4-H Office will distribute additional tickets upon request to Club Sales Chair. Please call or email half a day in advance to request more tickets.
- For each distribution a new Distribution Contract will be completed and signed by the Club Sales Chair.

Payments

- All checks for tickets being sold should be made payable to your club. EXAMPLE: On Target 4-H

Clubs Sales & 10% Incentive Rules

- Clubs will receive 10% of raffle ticket sales from their club members.
- There will be no required club minimum to receive 10% of total sales.
- Clubs must submit a Club Total Sales sheet at the **April 1st deadline**.
- Clubs must pay for sold tickets with 1 club check and return any unsold tickets, when turning in tickets.

Awards

- Top five 4-H sellers will receive a personalized belt buckle at Awards Banquet.
- The Parents Association will recognize clubs who sold tickets at the Awards Banquet.
- Top sellers (both members and clubs) will not be disclosed until the Awards Banquet.

Clubs that do not have a club bank account CANNOT sell raffle tickets.
