Tickets may be picked up **March 4th** from the 4-H office.
2026 rule changes are **highlighted**.

Raffle Club Rules for 2026

- There will be only **2500** tickets to be sold during the duration of the raffle.
- The price is set at \$20.00 per ticket.
- The purchaser must be at least 18 years of age and does not need to be present to win.
- The drawing will occur at the **Brazoria County Council meeting, April 27, 2026**. Watch the drawing live on the Brazoria County 4-H Face Book page - <https://www.facebook.com/brazoria4h>
- Prizes must be collected within 30 days of drawing, or they will be forfeited to Brazoria County 4-H.
- **Prizes must be picked up at Skeeters Gun Range - 2100 FM 2004, Richwood, TX 77531**
- Winners will be contacted and will be required to present ID to claim gift certificate for the amount of the listed price of the firearm on the ticket.
- Clubs and members missing unsold tickets at time of turn in are responsible to pay for missing tickets.

Deadlines & Rules – Both deadlines will count towards 10% club profit checks, and top seller totals.

- **April 1st, 2026**
 - **Any unsold tickets by members must be turned in at this time by Club Sales Chair to the 4-H office between the hours of 8:00 am – 4:30 pm.**
 - **Must pay for sold tickets with 1 club check. No cash will be accepted.**
- **April 3rd, 2026**
 - **Members may pick up raffle tickets from the 4-H office between the hours of 8:00 am – 4:30 pm.**
- **April 15th, 2026**
 - **Any unsold tickets by members must be turned into the 4-H office at by club members guardian or Club Sales Chair.**
 - **Must pay for sold tickets with 1 CHECK or MONEY ORDER. No cash will be accepted**

Distribution & Turn in of Tickets

- Initial distribution of tickets will be based on **60% # of club members/40% of tickets sold during the 2025 fundraiser weighted distribution formula**. Total number distributed **will** be rounded down to the nearest 5.
- Member **re-distribution** of tickets **on April 3rd** will depend on how many tickets are turned in on April 1st. **Cassidy will determine how many tickets will be given to members.**
- If a club did not sell tickets during 2025 fundraiser, **the club will be called to determine their interest in selling for 2026**. Distribution of tickets **will be based on a maximum of 3 tickets per club member or reasonable request by the Club Sales Chair.**
- The 4-H Office will distribute additional tickets upon request to Club Sales Chair **or a member's Guardian depending on the date of request**. Please call or email half a day in advance to request more tickets.
- For each distribution a new Distribution Contract will be completed and signed by the Club Sales Chair **or member guardian depending on the date of request.**
- **Tickets must be turned in in numerical order.**

- People who purchase tickets must put their real name. It CANNOT be a nickname, business, ranch, etc.
- It is the 4-H members responsibility to put their name as “Seller” on raffle ticket to receive credit.

Payments

- All checks for tickets being sold should be made payable to your club. EXAMPLE: On Target 4-H
- Clubs will pay for sold tickets with 1 club check made payable to: Parent Association of Brazoria County 4-H. No cash will be accepted.

Clubs Sales & 10% Incentive Rules – If your club does not have a bank account, the club cannot receive an incentive check.

- Clubs will receive 10% of raffle ticket sales from their club members.
- There will be no required club minimum to receive 10% of total sales.
- Clubs must submit a **Club Total Sales Sheet** at the **April 1st deadline.**
- Clubs must pay for sold tickets with 1 club check and return any unsold tickets, when turning in tickets.
- Club name must be on ticket to receive sales credit.

Awards

- Members who sell 40+ tickets will be invited to a party determined by Cassidy at a later date.
 - Belt Buckles will not be awarded to top 5 sellers.
- The Parents Association will recognize clubs who sold tickets at the Awards Banquet.
- Top sellers (both members and clubs) will not be disclosed until the Awards Banquet.

Clubs that do not have a club bank account CANNOT sell raffle tickets.
