Projects and Priorities

A brief presentation included instructions for building on the pool of project ideas, including questions to guide the exercise:

- Is there an education or outreach opportunity?
- How can we benefit multiple watersheds or communities?
- Are we the group to implement the idea?

The Coalition will aim to complete six education/outreach efforts before Thanksgiving 2021.

Review project opportunities and refine project strategies and actions.

Project idea - **Policy decisions regarding dredging** – Outreach to policy makers on policy decisions regarding dredging

- What are the interactions between cities, drainage districts, and counties?
- Workshop of flood education targeted to city leaders/officials; post Harvey status/actions; jurisdictions-who does what?; Dickinson first, then other watersheds?
- Evenings might be better for elected-appointed officials
- Drone flight/other information on bayous for the presentation can show multiple waterways this way
- Boat ride for local officials
- What development is allowable along the banks of the bayous? What permits are needed? How are these developments approved?
- Approach drainage districts for understanding of what they can do; maintenance approaches past and future; work with those who are willing

- Some areas are not maintained by drainage districts or another entity
- These agencies do not have a lot of funding; need to get everyone together in one room
- Neighborhoods and waterways are connected
- Dredging requires approval
- Dickinson Bayou Steering Committee is another group in the area

Project idea - **How bayous operate and tidal movement of sediment** – Public interest and misconceptions on how bayous operate, dredging versus drainage maintenance, and the tidal movement of sediment

- The width and adjacent properties along Dickinson Bayou have changed a lot over the years.
- Alternatives to dredging for flood control; room for more than dredging
- Topography in Brazoria County is conducive to flooding
- GCHD pollution control and HGAC have collected bathymetry and cross section data of Dickinson Bayou to see the physical structure

Project idea - Riparian buffer, Low impact development, and Erosion Control – Riparian buffers, various household-based LID practices, and other erosion control measures

Project idea - **Outreach to boaters on shoreline erosion** – Outreach to boaters regarding boater responsibility and shoreline erosion
