Contest Highlights

3. **Consumer Decision Making Contest** – Evaluate products, make informed choices, and explain your reasoning.
4. **Photography Contest** – Open to all youth, including Cloverbuds. Two deadlines must be met. Digital and physical submissions required. Photos will be displayed at Roundup, in the North Dallas Government Building lobby for one month.
 - February 9th – Digital entries must be submitted online for judging.
 - February 16th – Each photo submission should be mounted on 8x10 mat board and delivered to our office (6820 LBJ Fwy, Dallas) with a label attached indicating the participant's name, age division and category
5. **Entomology Contest (NEW!)** – Explore the fascinating world of insects through identification and classification challenges.
6. **4-H Project Spotlight: Tabletop Edition (NEW!)** – Showcase a 4H project of your choice using a tabletop display.
7. **Talent Show** - Showcase your talent through vocal or instrumental music, skits, dance routines, poetry/prose, or other performance acts.

Registration. Each participating member is required to [Register Here](#) at no cost. Registration opens on January 5, 2026 and closes at midnight on February 16, 2026. **No late registrations will be accepted.**

Participation. Participation is open to Dallas County youth and current 4-H members. However, the event will give priority to current 4-H members and organizations that are in the process of being chartered. Participants must be eligible to compete according to UIL rules.

Please note that this event is NOT a qualifier for District IV and State Public Speaking competition. However, if participants are interested in participating in the District IV Public Speaking contest, please visit: [District IV Public Speaking Contest](#).

NOTE: Registration for the District IV Public Speaking contest opens March 4th and closes midnight March 18th, 2026. **No late registrations will be accepted, and it is open to 4-H members only.**

We encourage participants to register as soon as possible and use the Dallas County Roundup as an opportunity to practice your speech!

Age Divisions. Age divisions are determined by a participant's grade as of September 1, 2025, of the current 4-H year. Age divisions for this contest are:

Junior	Ages 8-10 (Grades 3, 4, 5)
Intermediate	Ages 11-13 (Grades 6, 7, 8)
Senior	Ages 14-18 (Grades 9, 10, 11, 12)

Contest Divisions. Contestants will be assigned by rooms in each age division.

Entries. There is space for 10 participants per age group. Please register as soon as possible to secure a spot!

Eligibility. Public Speaking presentations are ONLY an individual effort regardless of their age division.

Originality. Public Speaking presentations MUST be persuasive based on the topic selected.

Topic Subject. Subjects in public speaking presentations should intend to persuade an audience on a desiring /provoking and emerging / current issue or topics. Senior contestants are encouraged to research these emerging and/or current issues to develop a speech.

Judges' Gifts. Gifts of any kind MAY NOT be presented to the judges in any contest.

Awards – There are two types: 1) Quality Award. Blue, Red, and White Participation quality awards will be given based on the total score value. **2) Best of Division.** A Best of Division ribbon will be awarded to one participant in each age division and category. Score ranges for each award are outlined on the attached score sheet. **County Roundup is not a pre-qualifier for District IV Competition.**

PUBLIC SPEAKING CONTEST RULES

- Speeches should be between 5 - 8 minutes. Point deductions will be taken for those under/over.
- The presentation should serve to persuade others regarding a particular issue or concern. It should also be appropriate for the members' age and experience. Appropriate credit must be given for references used.
- Public Speaking Score Sheet Version V.2023 will be used for the contest.
- **Visual aids and props may not be used.**
- Following the speech, there may be up to 5 minutes of question-and-answer period by the judges. Only official judges and superintendents may ask questions of the contestants.
- Contestants may be asked to provide the title of their speech and a short statement related to what their speech is about at the time of registration.
- Speeches MUST be the original work of the participant. Contestants may NOT share/utilize the same presentations delivered by other members/siblings/family members.

Registration. Each participating member is required to register at the following link: [Educational Presentation Registration](#). No registration fee is required. Registration will open on January 5, 2026 and close at midnight on February 16, 2026. No late registrations will be accepted.

Participation. Participation is open to Dallas County youth and current 4-H members. Contestants must also be academically eligible (according to [UIL rules](#)) to compete on the day of the contest. A contestant may compete as an individual or as a member of a team. This contest is not a qualifier for District or State contest, although, it is encouraged for all Dallas 4-H members for participation and practice. [District IV Competition](#) is on April 10, 2026. Must be a 4-H member to participate in District IV.

Age. Age divisions are determined by a participant's grade as of September 1, 2025. Age divisions for this contest are:

Junior	Ages 8-10 (Grades 3, 4, 5)
Intermediate	Ages 11-13 (Grades 6, 7, 8)
Senior	Ages 14-18 (Grades 9, 10, 11, 12)

Eligibility. Educational Presentations may be an individual effort or conducted by a team of two participants.

Originality. Educational Presentations **MUST** be the original work of the youth participant. Youth may **NOT** share/utilize the same presentations delivered by others in the past.

Topic Subject: Subjects in the educational presentations should address emerging or current issues in each of the contest areas. Some contests provide a suggested list of topics that the educational presentation may cover along with a resource list. Senior contestants are encouraged to research these emerging and/or current issues to develop presentations. See the links below for the topic categories.

Accuracy of Information/Resources. With the computer and internet being used heavily in educational presentations, participants must know the difference between research and non-research based information. Contestants are required to use information that is factual and can be supported through adequate documentation. Examples of such websites are federal, state, and local governments, independent research sites, and Texas A&M AgriLife Extension Service websites. Internet information that is questionable includes personal documentation sites, chat rooms, message boards, etc. Participants must prepare a list of references (i.e. bibliography, works cited) for their presentation.

Subject Matter. The skills and knowledge used in any 4-H contest should be the result of experiences in a project in which the participant has participated. A presentation must relate to the contest entered, contain current information, and not be better suited for another contest. It should also be appropriate for the participant's age and experience. Appropriate credit must be given for references used.

Educational Presentations Contest Rules

Time Limits. A time limit of 12 minutes will be allowed for each educational presentation. An additional nine minutes will be provided for on-stage arrangements and cleanup in connection with the presentation. A penalty of two points per minute or partial minute overtime will be deducted from the final score. Following the presentation, there may be up to 5 minutes of question and answer period by the judges.

Visuals. Charts, photographs, computer graphics, and other visual materials are permitted and should enhance the presentation by clearly supporting the participant's message. Visuals must be appealing, easy to read, and easily seen by the audience—choose materials with this in mind.

While posters or pictures of restricted items are allowed, the following may **not** be used in any Roundup contest: firearms, weapons, fireworks, open flames, live ammunition, or live animals. Choose your visual taking that into consideration.

Judges' Questions. Judges may ask contestants questions at the end of their presentation. Following the presentation, there may be up to 5 minutes of question-and answer period by the judges. Only official judges and superintendents may ask questions of the contestants.

Score Sheets. 4-H Educational Presentation Score Sheet, V 2023 will be used by contest judges in scoring educational presentations regardless of presentation style (method demonstration, illustrated talk, or speech). Separate score sheets are used in public speaking. All score sheets are available on the Texas 4-H Youth Development website.

Judges' Gifts/Handouts. Gifts of any kind MAY NOT be presented to the judges in any contest. Handouts may be made available to the entire audience.

Use of Firearms, Weapons, Fireworks, Open-Flamed Burners and/or Ammunition. No firearms, weapons, fireworks, open-flamed burners or live ammunition are allowed to be used in any Roundup contest. However, posters and pictures of such items are allowed and encouraged. No items and/or props that are combustible, flammable, or under extreme pressure can be used in any Roundup contest. These include camp stoves, propane tanks, and/or open flames.

Live Animals, Insects, and Reptiles. No pets or live animals/insects/reptiles are permitted for use by contestants in a contest. Service animals are permitted in accordance with ADA regulations. If you have questions on other items that may not be allowed, it is highly recommended you contact the local County Extension Agent and/or the District IV Extension Program Specialist – 4-H Youth Development.

Service Animals. Service animals that are individually trained to do work or perform tasks for persons with disabilities are permitted at the event. Non-service animals are not allowed. Comfort or emotional support animals are not service animals.

Equipment. There are limitations or recommendations for juniors and intermediates as it relates to equipment and visual aids. Outlined below are the age-division specific rules for educational presentations:

Juniors	Intermediates	Seniors
No computer aided/projected presentation equipment allowed. Posters and an easel are a suitable and recommended alternative. Props and other visual aids are allowed.	Computer-aided presentation equipment is allowed, but posters are highly recommended and encouraged. Props and other visual aids are allowed.	Any type of presentation equipment, props, and visual aids are allowed (if also allowed by state rules).

Participants are required to bring 100% of their own equipment (props, posters, easels, personal computer, visual aids, extension cords, etc.), with the exception of a screen, table and projector, which will be available in each presentation room. It is also encouraged to bring your own adapter in case your computer does not have a HDMI port.

Take into consideration that Internet connectivity may not be available. Be prepared to incorporate any video or other graphics that may require Internet to be directly embedded in the presentation. Make sure the image/video is included as part of the thumb drive or method used to provide your presentation to the contest Superintendent/Coordinator.

Contest officials will not have any equipment such as computers, projectors, or video adapters available. It is the contestant's sole responsibility to secure and bring all necessary equipment, and to know how to operate and troubleshoot it. Please have your presentation pre-loaded on your computer.

FYI to Senior Contestants that advance on to Texas 4-H Roundup All presentations must be in some form of Microsoft Office (PowerPoint, Word, or Excel). All fonts used must be true type. These fonts specifically include Arial and Times New Roman (See Texas 4-H Roundup Rules & Guidelines for more information). Dallas County 4-H Roundup is not a prequalifier for Texas 4-H Roundup.

Awards. Quality Awards: Blue, Red, and White Participation quality awards will be given based on the total score value. Best of Division: Best of Division Rossett will be awarded to one participant in each age division and category. Score ranges for each award are outlined on the attached score sheet.

County Roundup is not a prequalifier for District IV Competition. 4-H Member participants can view District IV Educational Presentation rules [here](#). It is the member's responsibility to register for the contest on [4-H Online](#). District competitors must be enrolled in 4-H.

Participation. Participation is open to Dallas County youth and current 4-H members.. Contestants must also be academically eligible (according to [UIL rules](#)) to compete on February 28th, the day of the contest. A contestant may compete as an individual or as a member of a team. **This contest is not a qualifier for District or State contest, although, it is encouraged for all Dallas 4-H members for participation and practice. [District IV Competition](#) is on Friday, April 10, 2026. Participant must be a 4-H member to compete in District.**

Age. Age divisions are determined by a participant’s grade as of September 1, 2025. Age divisions for this contest are:

Junior	Ages 8-10 (Grades 3, 4, 5)
Intermediate	Ages 11-13 (Grades 6, 7, 8)
Senior	Ages 14-18 (Grades 9, 10, 11, 12)

Entries Per Member. Each member may enter an unlimited number of teams/individuals per age division listed above.

Members Per Team. Teams consist of 3 or 4 participants. Junior members will be allowed to move up to the intermediate age division in order to complete a team. Juniors and intermediates

are not allowed to move up to the senior age division. **Senior teams MUST BE in grades 9th-12th. No mixed age division for senior teams.**

Suggested materials to bring for contest: Clipboard, blank paper, and pencils. No calculators allowed. **CDM Work Sheet will be available for all participants.**

Awards: Quality Awards: Blue, Red, and White Participation quality awards will be given based on the total score value. **Best of Division:** A Best of Division Rossett will be awarded to the high point team in each age division. Score ranges for each award are outlined on the attached score sheet.

County Roundup is not a prequalifier for District IV Competition. Participants can view District IV Consumer Decision Making rules [here](#). It is the member's responsibility to register for the contest on [4-H Online](#). **District competitors must be enrolled in 4-H.**

Last Revised: January 2026

PURPOSE

The Dallas County 4-H Photography Contest encourages self-expression and allows youth to demonstrate skills learned in the area of photography, including the use of photographic equipment and processing of photographs.

OBJECTIVES

- To develop skills in composition, light, story line, posing, and awareness.
- To gain knowledge about cameras, camera settings, photography dimension and resolution.
- To encourage 4-H members to use photography as a meaningful communication tool in their lives.
- To provide a photography project showcase opportunity for senior 4-H members.
- To continue to share the message of 4-H.
- To utilize photographs which can promote and strengthen the 4-H program.

RULES AND PROCEDURES

Participation Grades	Clover Buds K-2 Junior: grades 3-5; Intermediate: grades 6-8; Senior: grades 9-12 All ages of September 1, 2025
Photo Eligibility	All photos must be taken with a digital camera (smartphone cameras are included). Photo must be taken by participants between the dates of January 1, 2025 and the time of entry. Photos may be submitted only one time and in only one category.
Photo Format	Must be .jpeg, .jpg, Contestants may use any file naming structure. No RAW files or .png allowed. (updated; removed .png *Please remember to save each photo entry as "category_lastname_firstname.jpeg, or jpg.")
Qualifying from County	Each member may enter only one entry per category for a total of 18 entries. Dallas County will determine which photo will advance in the 18 categories. (Senior Members Only)
Entry Fee	There are no entry fees. However, this year we require that all photos be printed and mounted for display. The only cost involved will be for printing and mounting the images.
Photo Entry Method	Digital Submission: Members will submit digital photos through the Google form in using this link Matted photos: For display must be turned into the Dallas 4-H Office by deadline.
Deadlines & Entry Period	Submissions of the digital on Google Form opens January 5, 2026 and close on February 9, 2026, at 11:59pm. Mounted photos are due in our Dallas County Office, no later than 4:00 PM on February 16, 2026. **No late submissions will be accepted**

Event Name	2025-2026 Dallas County 4-H Photography Contest
Ratio and Size	<p>Size Ratio: any size ratio, except for panoramic, is acceptable. For this contest, panoramic is defined as a photo with an aspect ratio of 3:1 or 1:3 or wider/taller. File Size: Photo must be a minimum of 1 MB (1,000 KB) and a maximum of 20 MB.</p> <p>*Seniors who qualify for State are responsible to submit photos with a maximum of 20MB.</p> <p>Tips: Upload the highest resolution possible. Review your photo at 100% size before uploading. Check your photo's file properties and/or metadata to ensure it meets the file size requirements. 1 MB (megabyte) is equivalent to 1,000 KB (kilobytes). Photos that are less than 1,000 KB do not meet the minimum file size requirement.</p>
Alterations	Color and Black & White photos are allowed in all categories. Although slight computer enhancements are allowed, such as cropping, minor adjustment of lighting, and red eye reduction; substantially altered photography, such as applying design styles, or using computer graphics will disqualify an entry. Any other alteration, manipulation, or edits to a photo would require the photo to be entered into the Enhanced category.
Text on Photographs	Photographs must not contain camera or user placed text. This includes such things as date stamps, comments, watermarks, or titles. Text or wording that is part of the original photograph (i.e. photo of a street sign, etc.) is acceptable.
Copyright/ Original Work of 4-H member	The entry must be the original photographic work of the 4-H member and not a photo taken by family members, other 4-H members, or secured from any other printed/electronic source. Any photo proven to be found as not original work will result in disqualification of ALL the 4-H member's entries into the Photography Contest. Additionally, actions may be taken against the 4-H member in regards to the Consequences of Misbehavior and Code of Conduct signed by the 4-H member.

AWARDS, DISPLAY AND JUDGING

Awards and Recognition	<p>Quality Awards: Blue, Red, White, and Green (Participation ribbon) quality awards will be given based on the total score value. Score ranges for each award are outlined on the attached score sheet.</p> <p>Best of Category Awards: A Best of Category Ribbon will be awarded to the highest-scoring blue ribbon photo entry in each age division and category.</p> <p>*Senior level best of category photos will qualify to State Competition, member is responsible to submit to State by deadline.</p> <p>Best of Age Division: A Best of Age Division Rosette will be awarded.</p>
Judging and Results	For Quality Awards, each photograph will be judged against a set of judging criteria, and not against photographs of peers. Based on total points awarded for each photograph, the participant will be awarded either a blue, red, white, or a participation ribbon (outlined on the attached score sheet). The Best of Categories is a competitive process whereby judges will select the best photo within a given category. Volunteer judges will make those determinations and all decisions are final. Results will be available on the Dallas County 4-H Website after Judging is complete.

Roundup Display and Participation	<p>Print size: 8x10 inches. Mounting board: mounted photo to matboard (similar to this link), or mat cut flush to edge of photo without framing, no overhang or frame. Mat Color: Color of board does not matter as there is no frame or edge shown. Participant's name, club name (if applicable) category and age division must be labeled on the back. The mounted photos will first be displayed at Roundup. Another possible display location will be announced soon.</p> <p><u>Note: Participating in Roundup is optional for photography contestants; it's not a requirement.</u></p>

Documentation should be retained by the participant and be available upon request from the Texas 4-H Youth Development Program.</p>

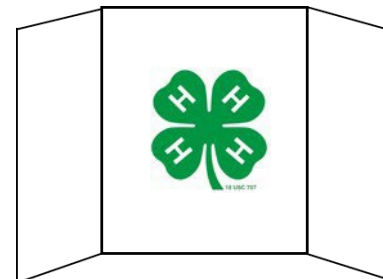

Accuracy of Information/Resources. Contestants are required to use information that is factual and can be supported through adequate documentation. Examples of such websites are federal, state, and local governments, independent research sites, and Texas A&M AgriLife Extension Service websites. Internet information that is questionable includes personal documentation sites, chat rooms, message boards, etc. Participants must prepare a list of references (i.e. bibliography, works cited) for their exhibit.

Subject Matter. The exhibit must relate to the project area entered, include current and accurate information, and be appropriate for the member's age and experience level. Exhibits should be original and fit in the category. Proper credit must be given for all references and sources used.

4-H Tabletop Member Exhibit Contest Rules

- One entry per exhibitor
- Open to clover buds, juniors, intermediates and seniors.
- Tri-fold Board up to 36" x 48" accepted
- All tabletop exhibits must demonstrate one main theme or idea and teach about the project.
- The entry may include items that represent the project or have been created by the exhibitor to be displayed in front of the tri-fold board.
- Exhibits will be judged on both visual quality and content including drawing attention to viewers, well planned/organized and pleasing appearance and appropriate content for project and age of 4-H member.
- Entries must be original each year and must be created by the 4-H member entering the exhibit.
- The back of the display should include Member Name, County, 4-H Club, 4-H Age, and Category.
- A 4-H emblem, AgriLife, Prairie View & Dallas County logo must be included somewhere on the exhibit. (See attached logos)
- Include citations for sources of information and photos either at the bottom of the front or on the back of the display board.
- **No flammable, combustible, or sharp items** are allowed in any Roundup contest to display. This includes firearms, weapons, fireworks, camp stoves, propane tanks, open flames, or pressurized containers. Pictures of these items are allowed and encouraged.
- **No live animals or insects.**

Service Animals. Service animals trained to assist individuals with disabilities are allowed at the event in accordance with ADA regulations. Comfort or emotional support animals are not considered service animals and are not permitted. If you have questions about what is allowed, please contact your County Extension Agent.

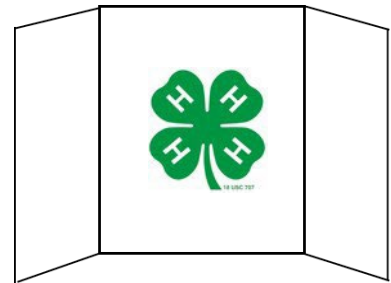

Registration. Each participating member is required to [Register Here \(at no cost\)](#). Registration opens on January 14, 2026 and closes at midnight February 16, 2026. No late registrations will be accepted.

Participation. Participation is open to current 4-H members and any Dallas County youth. However, the event will give priority to current 4-H members and organizations that are in the process of being chartered. Contestants may compete as an individual or a team. Only contestants may be part of any said performance. Contestants can only choose one performance from all categories; they are not allowed to mix participants from different age divisions. If the performance is musical, contestants must bring their own instrument(s). Contestants compete at their own risk. Stretching, vocal warmups, and tuning-owned instruments are recommended before entering the stage for performances.

Age Divisions. Age divisions are determined by a participant's grade as of September 1st, 2025. We will NOT allow contestants to mix individuals from different age divisions. The age divisions for this contest are:

Junior	Ages 8-10 (Grades 3, 4, 5)
Intermediate	Ages 11-13 (Grades 6, 7, 8)
Senior	Ages 14-18 (Grades 9, 10, 11, 12)

Entries. Each club, institution and/or community organization may enter an unlimited number of individuals or teams per age division listed above, however; due to limited space and time for the contest, **we are capping the event to 20 contestants. The limit number of participants for teams is nine (9) individuals per category in each age division.**

Categories. There are seven (7) categories, each with a separate description and score card. Category descriptions are listed in the Texas 4-H Roundup Guide and in the enclosed Contest and Category Descriptions.

NOTICE: all categories in all age divisions will happen on the same day because of limited access to facilities and strict scheduling.

Category Reference

- Solo / Band Performance
- 4-H Skit
- Instrumental Music
- Choreographed Routine
- Poetry / Prose
- Vocal
- Variety Show

To determine a category entry, refer to the descriptions on the enclosed contest and category descriptions. The County Extension

Agent(s) will review entries for proper category, appropriateness of material, and ensure that all other rules and regulations are followed.

1. **Advancement to Texas 4-H Roundup.** This is not a qualifying event for the District or the Texas Round Up. Instead, it is an opportunity to practice and learn more about the structure for future contest opportunities.
2. **Presentation Material.** Participants must compete with the same material at all levels of competition – They are not allowed to change their performance or songs for State level competition. Acts may fine-tune performances based on critiques from County and State judging, but changing material completely is prohibited.
3. **Judges. Judges/Superintendent will determine:**
 - a. If an entry is in the correct category.
 - b. Placings of all acts/performances.
 - c. The judges' decisions will be final.
4. **Props.** Regulations for props should be followed. Props utilized must be able to go through doors that are 6 ft. wide and 7 ft. tall. Each entry will be allowed to bring props that will be able to be stored in a space that is 3 ft. X 8 ft. Space at the county contest is limited!

5. **Prohibited Materials.** The following materials may not be used in any category: talcum powder/baby powder, flour, pies, food, water, oil, loose feathers, flower petals, hay, straw, helium balloons, glitter, sand, confetti, open flames or other substances which are hard to clean up, may cause damage, or be dangerous to participants. No roller skates, shoes with spikes, cleats, motorized vehicles, or live animals will be allowed. Any prop resembling a firearm must receive prior approval.
6. **Time Limits.** Time limits for all categories will be strictly enforced. All categories have a time limit of six (6) minutes for presentation and four (4) minutes for set-up, soundcheck, and breakdown, for a total of ten (10) minutes per act. A penalty of five (5) points per minute or part of a minute over the time limits allowed will be deducted from the total score.



Reminder

7. **Introduction to the Act.** Contestants do not need to introduce themselves. All families will need to complete the online information that will be in the google registration form. Anything that needs to be said should be included in the introduction from the online submittal form to be read by the announcers; however, if you choose to add information, it will count against your performance time. (See Act Description Attachment) County description should not be more than 75 words in length.)

8. **Storage of Props.** Props will be unloaded and set in assigned locations by team members. Please be courteous of others' props and minimize the space that you use. Please note that this may not be behind the stage.

9. **Adult Assistance – Set-up.** Only adult coaches and/or agents will be allowed backstage, in the vicinity of the storage area of props, and to assist the contestants with set-up and breakdown of props and equipment. Other youth who are not a part of the team **will not** be allowed to assist with set-up or take down. One person should be designated by the group to work with the stage manager when it is your turn to set up your performance. This person should know the exact locations for all equipment, props, etc. on stage and be able to give clear instructions.

10. **Adult Assistance - Performance.** During a performance, adult coaches may give cues for music backstage and help with costume/prop changes backstage. They are NOT allowed to participate in any other form in the act while the act is going on. Any voices heard during the performance from backstage must be either a participant OR with a recorded voice.

11. **Music.** No live companionship will be permitted for any category. If music is required for the performance, it must be performed by the contestant or on a flash drive in MP3 or MP4 format. Contestants **MUST** bring recorded music on a flash drive. **No music will be allowed to play from smart phones, boom boxes, etc.** See Category Descriptions for specific rules for each

category.



12. No Stage Practice/Warm Up. Because scheduling at County Roundup is tight, there will be NO practice walk through or warm up on the stage. Contestants should rehearse and come prepared to present a top-notch performance.

There will be time for sound check during your two-minute set up directly before your performance. After you have registered, go to the sound technician and make sure they know who you are, that you have checked in and give your flash drive to the technician. (Make sure your name is on the flash drive.) The schedule does not allow time for practice. This is a sound check only.

13. Recording & Photos. Due to the Texas 4-H Photography Waiver and copyright laws, viewers will be able to record or photograph their children **ONLY**. No flash photography for the safety of performers and do not block other viewers while recording or taking photos.

CONTEST AND CATEGORY DESCRIPTIONS

ENTRIES:

INDIVIDUAL OR TEAMS (Maximum of nine participants per team) 4-H Skit, Choreographed Routines, Variety Show, Musical/Instrumental, Poetry/Prose, Solo/Band Performance, and Vocal.

OBJECTIVES:

- To provide an opportunity for 4-H youth to develop a spirit of cooperation through working together to develop self-confidence through public appearance.
- To stimulate interest and encourage a broad-based recreation program in Texas 4-H at the club and county level.
- To encourage 4-H members to discover and develop their talents.
- To provide for social, cultural, and leadership development of 4-H youth.

1. **4-H SKIT.** An entry may consist of one (1) to nine (9) participants. May be a 4-H based story line, promoting 4- H, community service, a project or activity. This category may also address a specific youth issue and present ways in which this issue can be addressed through 4-H efforts. May incorporate music, vocal selections, and/or choreographed routines, but these aspects cannot be more than half of the performance. Skits can be humorous, creative and, make fun of but not degrade Extension employees or the 4-H program. All 4-H members entered in the category must be part of the act. Judging on material chosen, talent, creativity, showmanship, costumes and props. Four (4) minutes for set-up and breakdown; a maximum of six (6) minutes for presentation for a total of ten (10) minutes per act.

2. **CHOREOGRAPHED ROUTINES.** An entry may consist of one (1) to nine (9) participants. No speaking to form a skit or story line. The act requires choreography and can be demonstrated through twirling, pom-pom squad routines, jump rope teams, basketball dribbling exhibitions, or dance (jazz, tap, country & western, ballroom, etc.). Sign language presentations to music have been added to choreographed routines. However, if a participant is SINGING and SIGNING, this entry should be entered in the Vocal Category. All 4-H members entered in the category must be part of the act. Acts may use recorded music previously uploaded in the Google form. Participants may not

use an accompanist. Judging on material chosen, talent, creativity, showmanship, costuming, and material chosen. Four (4) minutes for set-up and breakdown; a maximum of six (6) minutes for presentation for a total of ten (10) minutes per act.

3. **VARIETY SHOW**. An entry may consist of one (1) to nine (9) participants. This is an acting category. Variety show, also known as variety arts or variety entertainment, is entertainment made up of a variety of acts including sketch comedy, magic, acrobatics, juggling, and ventriloquism and other acts that do not fit into the other six categories. **Acts cannot incorporate 4-H related material or theme.** (Otherwise, it would be categorized as Celebrate 4-H.) Creativity is encouraged, but the degradation of any individual or organization is not permitted. May incorporate music, vocal selections, and/or choreographed routines, but these aspects cannot be more than half of the performance. Judging on material chosen, talent, creativity, showmanship, costumes and props. Four (4) minutes for set-up and breakdown; a maximum of six (6) minutes for presentation for a total of ten (10) minutes per act.
4. **INSTRUMENTAL MUSIC**. An entry may consist of one (1) to nine (9) participants. Musical presentations may be musical instruments accompanied by background recorded music or an instrumental performance only. No accompanies will be allowed. Participants may not sing or incorporate a skit, poetry, prose, or choreography with their act. Judged on talent, showmanship, musical presentation, and material chosen. Four (4) minutes for set-up and break down; maximum of six (6) minutes for presentation for a total of ten (10) minutes per act.
5. **POETRY / PROSE**. An entry may consist of one (1) to nine (9) participants. Acts which showcase poetry or prose are required. The act may NOT incorporate a vocal, musical, and/or choreographed routine. This category does not require 4-H related material; however, if an original poem or prose piece showcasing 4-H is written, this would be acceptable. Every 4-H member entered in the category must be a part of the performance on stage. **Materials do not have to be memorized.** Judged on material chosen, message, talent, presentation style, props/costuming. Four (4) minutes total for Set-up and breakdown; maximum six (6) minutes for presentation for a total of ten (10) minutes per act.

Defining Poetry and Prose: Poetry is generally characterized by structured meters and rhyme that tells a story or provides a message to the reader. Prose is distinguished from poetry by its greater variety of rhythm and its closer resemblance to the patterns of everyday speech. Another description might be an excerpt from a larger piece such as a play or book.

6. **SOLO / BAND PERFORMANCE**. An entry may consist of one (1) to nine (9) participants. This act incorporates a combination of vocal and musical/instrumental talents. Acts that are vocal or musical / instrumental only are not to be entered in this category. All 4-H members entered in the category must be a part of the act by playing a musical instrument, singing, or both (solo performance must play an instrument and sing). Participants MUST incorporate singing in the acts, but cannot incorporate skits,

poetry, or prose. They may, however, move around the stage and incorporate choreography with their presentation for the purpose of enhancing their showmanship. Judged on talent, showmanship, musical presentation, vocal presentation when applicable, and material chosen. Four (4) minutes for set-up and breakdown; a maximum of six (6) minutes for presentation for a total of ten (10) minutes per act.

7. **VOCAL**. An entry may consist of one (1) to nine (9) participants. Vocal presentations may be performed in a cappella or with an accompaniment with recorded music previously recorded on flash drive. No live accompanist will be allowed for this category. All members of the act must sing. No lip sync will be allowed. Contestants may not present skits, poetry, or other speaking during the act. They may, however, move around the stage and incorporate choreography with their presentation for the purpose of enhancing their showmanship. Sign language may be added to enhance performance, but entries that strictly showcase sign language without vocal presentation are not permitted in this category. They must be entered into Choreographed routines. Judged on talent, showmanship, vocal presentation, and material chosen. Four (4) minutes for set-up and breakdown; a maximum of six (6) minutes for presentation for a total of ten (10) minutes per act.
