

# **FORT BEND EEA 4-H LEADERSHIP LAB MINI GRANT**

## **Eligibility/Requirements**

1. Be an Active Fort Bend County 4-H Member.
2. Complete Fort Bend EEA Leadership Mini Grant Application and provide other required materials, including all required signatures.
3. All required paperwork must be turned into the County Extension Office FCH Department by **April 14 by 5:00 P.M.** Emailed applications will not be accepted.

## **Rules and Regulations**

1. For 2025, the value of the mini grant could be up to **\$150.00** to be paid upon returning from the District 9 4-H Leadership Lab. This grant is to help offset the total cost of the lab. There could be a maximum of three (3) grants awarded. Please note all applications may not receive a mini grant.
2. Fort Bend EEA members will review all submissions. Parents of applicants shall not be able to review submissions.
3. Important Dates:
  - a. April 30<sup>th</sup> Recipients will be notified by email if they have received the mini grant.
  - b. May 9<sup>th</sup> Recipients of the mini grant who are **NOT** able to attend the Leadership Lab will need to contact the Extension Office FCH Department by 5 pm.
  - c. May 14<sup>th</sup> Recipients of the mini grant will need to register for the event before this date on 4-H Online.
4. Request for payment must be postmarked by **July 8, 2025**. The request should also include a photo while attending District 9 Leadership Lab (name of lab when released) and a copy of the program agenda.
