## Open Youth Horse Show



Monday, April 23, 2018 Registration 12-1 p.m.; Show Starts at 1:30 p.m.

Registration Fee: \$10 per class. No stallions are permitted, mules are permitted. Age of horse and exhibitors is determined by age as of Jan. 1, 2018. Jr: 12 and under; Sr: 13-19 (must not have graduated from a secondary school). A current negative Coggins must be presented at registration. Awards, including buckles and conchos, will be given in each class.

Class List:

- 1) Halter – 2 years and under
- 2) Halter Mares – 3 and over
- 3) Halter Geldings – 3 and over
- 4) Jr Showmanship
- 5) Sr Showmanship
- 6) Lead Line – ages 7 and under
- 7) Jr Western Horsemanship - WT
- 8) Sr Western Horsemanship - WTC
- 9) Jr Ranch Horse Pleasure - WT
- 10) Sr Ranch Horse Pleasure - WTC

**Halter:** The horse is judged based upon conformation and resemblance to the breed ideal.

**Showmanship:** The exhibitor is judged on their ability to execute a pattern in hand.

**Horsemanship:** Judged based on rider position and skill in executing a pattern. No rail work in these classes.

**Ranch Horse Pleasure:** Horses shall be shown as a group in each class at the walk, extended walk, trot, extended trot, lope and extended lope in both directions. Riders will be asked to reverse, back and stop their horse.

**Attire:** Exhibitors must wear long pants, long sleeve shirt with collar, western hat or ASTM certified riding helmet, and western boots. Chaps or chinks are not permitted.
